Forgotten Shapes Type Foundry End User License Agreement (EULA) for Font Software

This is a contract between you and Forgotten Shapes GbR.

This License Agreement constitutes a binding legal agreement between the Licensee and Forgotten Shapes GbR (hereafter the "Licensor") and establishes the terms and conditions by which the Licensee is permitted to install and use the Font Software and any related items of the Licensor.

End User License Agreement (EULA)

The general Forgotten Shapes End User License Agreement (EULA) is a standard document that forms the basis of all licensing agreements.

Specific User License (SUL)

The Specific User License (SUL) document overrides the general Forgotten Shapes EULA in certain aspects, for example user parameters or usage details specific to the end user.

The two documents combined form the licensing agreement as a whole.

"Font Software" refers to coded software that generates typeface designs ("fonts") when used with the appropriate hard- and software, plus any and all other data including documentation provided with such software including updates, modifications, upgrades, or beta-versions.

By downloading, installing, and/or using the Font Software, the Licensee agrees to the terms of the EULA and SUL.

- § 1 License and Usage Rights
- 1.1. Upon full payment, the Licensor grants to the Licensee the limited, non-exclusive, non-assignable, non-transferable right to use the Font Software, in accordance with this EULA and Licensee's Specific User License (SUL).
- 1.2. DESKTOP/PRINT USE: The Licensee is permitted to install the Font Software on the number of computers and for the number of users within the Licensee's company specified in the SUL. The number of business locations where these computers/users are situated shall also be defined in the SUL. The standard desktop/print license covers up to three (3) users within one company/institution/freelance studio at one (1) business location (office, branch).
- 1.3. SERVER LICENSE: The Licensee may install the Font Software on a file server in a local network (LAN) that is not accessible via the internet. The server use is limited to the licensed number of users/workstations having access to the Font Software.

- 1.4. WEBSITE USE: For dynamic online rendering on websites, a web license is required. Web licenses are granted per domain and for specific page-view categories. The Font Software has to be hosted by the Licensee via CSS (Cascading Style Sheets). The CSS file linking to the webfonts must include the Licensor's disclaimer (§4.5).
- 1.5. APP USE: Licensing for embedding the Font Software in Apps for mobile devices is granted for a specific number of Apps and is limited to specific download rates. The Licensee may not embed or otherwise use the Font Software in any Mobile App that will be distributed to more than 500,000 end users within a 12 month period. If the Licensee exceeds this distribution limit, the Licensee must obtain a license upgrade. Apps with the same content on different platforms (e.g., iOS, Android, or Windows) count as one app.
- 1.6. DIGITAL ADVERTISING & SOCIAL MEDIA: For embedding/publication of the Font Software in Digital Advertising (online banner/web ads, video ads, email newsletters, digital point of sale) or in Social Media, corresponding licensing is required.
- 1.7. LOGO USE: Using the Font Software completely, partially, or modified to create static or animated Logos/Taglines/Brandmarks/Slogans, etc. is subject to an additional licensing fee for the public use of such a brand mark.
- 1.8. USE IN PDF FILES/STATIC PICTURES: The Licensee is permitted to embed the Font Software in static pictures (.gif, .png, .jpg, etc.) or converted into paths (.pdf). These documents may only be published in a secured format that permits only viewing and printing (i.e., read-only).
- 1.9. ADDITIONAL LICENSING: For any other usage of the Font Software, e.g. for TV broadcasting, Online TV, Film, Commercial Merchandising, eBooks/ePubs, embedding in other Software or Hardware, or any other font usage not mentioned here, the Licensee must apply for adequate licensing.
- 1.10. THIRD-PARTY USE: Each company/institution/free-lancer that installs the Font Software needs its own license.
- 1.11. As an exception to §1.10, the Licensee is allowed to transfer a copy of the Font Software for the exclusive purpose of outputting the pertinent file to a commercial printer or other service company. The document must not be edited by the printer or service bureau. In the event of any modifications to the document or use of the Font Software for other purposes, the printer or service bureau must purchase its own Font Software licenses.

Forgotten Shapes Type Foundry End User License Agreement (EULA) for Font Software

The Licensee may, for a defined period of time, provide a copy of the Font Software for a design to a company coding a website or a mobile application in the scope of a defined project, only to incorporate the Font Software into this particular website or mobile application and as long as the company doesn't use the Font Software on its own (editing, modifications, corrections, etc.). Otherwise, the company must purchase its own license. Any design and/or editorial work is excluded from this particular agreement.

The License of the Licensee is not transferred to the company or people in question and the Font Software may only be used to complete the work specified in the contract between the Licensee and the service company. Once the job is completed, the Font Software shall be deleted from the service company's computers. When providing a copy of the Font Software, the Licensee also has to provide a full copy of this EULA to the service company and inform them of the terms and conditions of this particular section.

- 1.12. Any modification of the Font Software, including customization, modification, variation, adaptation, or derivative work or conversion into other formats requires written permission from the Licensor. If permission is granted, the copyright for modified Font Software remains with the Licensor; modified Font Software, too, is subject to the terms of this EULA. Thus, modified Font Software must not be distributed in any way. Any non-compliance will be regarded as a breach of contract. In the event of unauthorized modification, the Licensor becomes the owner of the modified Font Software.
- § 2 Intellectual and Industrial Property Rights; Restrictions
- 2.1. The Licensee agrees that the Font Software is protected by the copyright law and other intellectual and industrial property rights of Germany, by the copyright law and other intellectual and industrial property rights of other nations, and by international treaties. This means that Licensees should treat the Font Software as they would any other copyrighted material, such as books, films, or photographs.
- 2.2. Any use contrary to this EULA and the Specific User License (SUL) can be legally prosecuted. Furthermore, the Licensor reserves the right to (a) claim subsequent license fees for use, (b) claim an additional penalty, which is at least 250% of the license fee, and (c) claim even more fees corresponding to the gravity of the infringement.
- 2.3. The Licensee may not duplicate, share, license, sell, rent, lease, transfer, assign, distribute, offer, or otherwise exploit the Font Software, or any portion thereof.

- 2.4. Licensees are prohibited from extracting, decompiling, modifying, reformatting, translating, reverse-engineering, assembling, redigitizing, or exposing the source code, as well as altering, removing, or obscuring the Licensor's proprietary notices, including copyright, trademark, or other legal notices.
- § 3 Trademarks of the Licensor
- 3.1. The Licensee agrees to use trademarks associated with the Font Software according to accepted trademark practice, including identification of the trademark owner's name. Trademarks can only be used to identify printed output produced by the Font Software. The use of any trademark as herein authorized does not give the Licensee any rights of ownership of that trademark, and all use of any trademark shall redound to the sole benefit of the Licensor. You may not change any trademark or trade-name designation for the Font Software.
- 3.2. All copies produced by the Licensee regarding this EULA must contain the same copyright, trademark, or other owner's marks, identical to the way they're represented in the Font Software.
- § 4 Guarantee, Liability, Waiver
- 4.1. The Licensee agrees that no software is ever completely flawless. This Font Software might also contain flaws, which could limit functionality and operation.
- 4.2. The Licensor guarantees to the Licensee that the Font Software will perform substantially as depicted in the documentation for the ninety- (90) day period following the receipt of the Font Software, when used on the recommended operating system and hardware configuration. The warranty does not apply to any Font Software converted, manipulated, or modified by the Licensee.
- 4.3. All warranty claims must be made, along with proof of purchase, within such ninety- (90) day period.
- 4.4. If the Font Software does not perform substantially in accordance with the documentation mentioned above, the entire liability of the Licensor and the exclusive remedy will be limited, as determined by the Licensor, either to replacement of the Font Software or to a refund of the license fee.
- 4.5. The Licensor disclaims all liability for any loss, cost, or damage, including without limitation indirect, special, consequential, or incidental damages, including any lost profits or lost savings, loss of goodwill, business interruption, work stoppage, loss of data, or computer failure, damage, or malfunction, or for any claim by any party, even

if the Licensor has been apprised of the possibility of such damages, and regardless of the theory (including contract, tort, strict liability, negligence, or otherwise) upon which such claim is based.

- 4.6. In no event shall the Licensor's total liability to the Licensee for all damages (other than as may be required by applicable law in cases involving personal injury) exceed the amount paid by the Licensee under this agreement. The foregoing limitations will apply even if the above-stated remedy fails in its essential purpose.
- 4.7. The Licensor shall not be liable for damages and the Licensee shall not have the right to terminate this Agreement for any delay or default in delivery of the Font Software resulting directly or indirectly from acts of nature, forces or causes beyond its reasonable control (Force Majeure) including, but not limited to: internet failures, network failures, computer equipment failures, telecommunications equipment failures, other equipment failures, electrical power failures, acts of God, terrorist action, acts of civil or military authority, government actions, fires, epidemics, riots, wars, sabotage, insurrections, labor shortages, or disputes.
- 4.8. The Licensor is liable for infringements of duty in the case of intent and gross negligence and also if an important contractual duty is infringed, provided that the attainment of the contractual goal is at risk (cardinal duty) and also for basic negligence. All other claims for compensation are excluded. This limitation of liability does not apply if the Licensor has assumed a guarantee for damages that must be compensated in accordance with statutory provisions and also for losses to life, body, and health.
- 4.9. Some states or other jurisdictions do not allow the exclusion of implied warranties, so the above exclusions may not apply to the Licensee. The Licensee may also have other rights that vary from state to state and jurisdiction to jurisdiction.
- § 5 Termination, Breach
- 5.1. The Licensor may terminate the Licensing Agreement immediately by notice (via email) to the Licensee upon failure by the Licensee to comply with the terms of this EULA, including, without limitation, by use exceeding the scope of use granted in the Specific User License (SUL).
- 5.2. The Licensor may terminate the Licensing Agreement or suspend the Licensee's rights to use the Font Software upon notice (via email) to the Licensee if:
 - 5.2.1. the Licensee or one of the Licensee's employees has materially breached any obligation of this agree-

ment and failed to cure the breach to the Licensor's reasonable satisfaction within fifteen (15) days following receipt of notice of the breach;

- 5.2.2. a third party has used the Font Software by employing the Licensee's access rights or the Licensee's copy of any software.
- 5.3. The termination of the licensing agreement shall automatically terminate and extinguish the Licenses granted herein. Upon any such termination, the Licensee shall immediately destroy the original and all copies of the Font Software in his or her possession and give notice about that to the Licensor. The Licensee shall have no further right to use the Font Software pursuant to this EULA. All confidentiality obligations of the Licensee under this EULA will continue for two (2) years after any expiration or termination of this EULA.
- 5.4. The Licensor reserves the right to (a) require that the Licensee immediately cease any unauthorized use in violation of the terms of this Agreement and (b) assess additional fees for the unauthorized use.
- 5.5. The Licensor's rights and remedies under this EULA shall be cumulative and not exclusive of any other rights or remedies provided hereunder or by law.
- § 6 License Fees, Payment, Ordering Process
- 6.1. The License Fee and the terms of payment depend on the purchased license, which the Licensee chooses during the ordering process.
- 6.2. The revocation of the License and the restitution of Font Software is not possible.
- 6.3. The Licensee shall only be entitled to offset counterclaims that are either uncontested or have been recognized by declaratory judgement.
- § 7 Obligations of the Licensee
- 7.1. The Licensee is obliged to do everything in his or her power to prevent a third party from accessing or copying the Font Software.
- 7.2. The Licensee informs all users who have legitimate access to the Font Software about the content of this EULA and ensures that they comply with its terms.

§ 8 Final Provisions

- 8.1. This EULA may only be modified in writing, which also applies to this provision concerning the written form.
- 8.2. If any part of this EULA is found void and unenforceable, it will not affect the validity of the balance of the EULA, which shall remain valid and enforceable according to its terms.
- 8.3. This EULA will be governed by the laws of Germany. This agreement will not be governed by the United Nations Convention of Contracts for the International Sale of Goods, the application of which is expressly excluded.
- 8.4. The place of performance for all performances arising from this EULA and the place of jurisdiction is Leipzig, Germany.
